The barns are let on the following terms and conditions:

Facilities: The barns complex consists of the Camping barn and an adjoining large Function barn which are let with Barn field for small groups and Cae hendre for large. There is also a barn yard for parking, with extra parking in Barn field for large groups by arrangement. A toilet block is in the yard and extra portaloos can be added. See our barns information sheet for more details of our barn facilities.

Conditions apply: The barns are available on these conditions:

- The maximum number of people at any function is 400.
- Vehicles are restricted to the barnyard unless as arranged for large groups.
- Fires only on steel firepits or on the fire site in Cae hendre field using only wood bought from us.
- Only acoustic music is allowed outside, and only during the day. Sound systems in the barns must be barely audible on the campsite prior to 11.30 pm and not audible on the campsite after this time. Sound levels depend on the weather and will be monitored by campsite wardens who must be respected if they ask for lower noise levels. A noise bond may in some cases be required.
- No excessive noise or disturbance is to be inflicted on the public campsite.
- Barn users must not camp on or visit the camping fields but are welcome on the beach.
- Barn groups must be respectful of other campers, especially those using the toilet block.
- Dogs are not allowed in the barns and must be kept on a leash at all times.
- No nails, staples or other sharp objects are to be used in any wood anywhere in barns.
- Barns and fields must be left tidy, rubbish in the bins and glass and cans separate for recycling.
- Security during your stay is your own responsibility. Keys to the outside doors will be supplied.
- Arrival time for the barns is after 2.00 pm, and please leave by 11.00 am unless otherwise arranged.

Event license: Barn users must arrange their own Temporary Event License from Gwynedd Council if alcohol is sold at the barns. Please note that this takes at least 10 working days. Phone Gwenda on (01758) 704 000 for details. Some providers of mobile bars will arrange this for you.

Charges: The cost of hiring the barns depends on the number of people using them.

- **Day visitors @** £3.00 per day, campers and those staying after midnight @ £9.00 / £11.00*.
- A **minimum charge** applies for the barns of £150.00 / £250.00* per night for the camping barn, sometimes reduced in the very low season, and £550.00 / £750.00* for all the barns.
- Please see our barn booking form to calculate details of the charges.
- **Saturday functions weekend rate:** Saturday functions will include access to the barns on Friday charged at £150.00 / £250.00*. This fee covers camping for up to 15 people and extras can be charged at the normal rate.
- A **refundable bond** of £100 / £200 for the camping / function barn is required.

Payment and arrival:

1. A **deposit**** of at least **£150 for the camping barn and £500 for the function barns** is due with the completed barn booking form.
2. **The balance due plus the bond** is due 4 weeks prior to arrival, based on estimated numbers.
3. **On arrival** go to the campsite reception and you will be escorted to the barns and given a barn arrival inspection sheet as well as keys to the outside doors.
4. **On leaving** go to reception, the barns will be inspected, adjustments to numbers confirmed and the bond refunded, unless you are using a non-payphone, see below.
5. A **payphone** is in the camping barn. Groups staying a week or more can have a non-payphone installed in which case they pay actual charges + 50%, which is cheaper than payphone rates. Phone charges are then invoiced and the bond refunded when payment of this invoice is made.
