The barns are let on the following terms and conditions:

**Conditions apply:** The barns are available on these conditions:

- Barn users are responsible for fire safety and must abide by displayed fire equipment instructions
- Woodburners in barns must be used with care, with moderate amounts of wood and no objects such as clothing placed close to them. Children must be prevented from being close to these fires.
- No portable heaters, catering equipment, candles, flares or fireworks to be brought on site.
- Arrival time for the barns is after 4.00 pm, and please leave by 11.00 am unless otherwise arranged.
- Vehicles are restricted to the barnyard unless as arranged for large groups.
- Fires: only using our wood and on firepits at least 6 m from barns, or on the firesite in Cae hendre
- Only acoustic music is allowed outside, and only during the day. Sound systems in the barns must be barely audible on the campsite prior to 11.00 pm and not audible on the campsite after midnight. Sound levels depend on the weather and will be monitored by campsite wardens who must be respected if they ask for lower noise levels. A noise bond may in some cases be required.
- No excessive noise or disturbance is to be inflicted on the public campsite. Barn users do not have the right to roam over the camping fields though they are welcome on the campsite beach. Barn groups must be respectful of the needs of other campers, especially those using the toilet block.
- Dogs are not allowed in the barns and must be kept on a leash at all times.
- No nails, staples or other sharp objects are to be used in any wood anywhere in barns.
- Barns and fields must be left tidy, rubbish in the bins and glass and cans separate for recycling.
- The maximum number of people at any function is 300.
- Security during your stay is your own responsibility. Keys to the outside doors will be supplied.
- Clean up: The barns are not serviced accommodation so it is required that you leave them in the tidy condition you find them. A refundable service bond of £100 for the camping barn and £200 for the entire complex is required with your fee.

**Event license:** Barn users must arrange their own Temporary Event License from Gwynedd Council if alcohol is sold at the barns. Please note that this takes at least 10 working days. Phone Gwenda on (01758) 704 000 for details. Some providers of mobile bars will arrange this for you.

**Charges:** The cost of hiring the barns depends on the number of people using them, whether they are used by outdoor groups or for weekend functions and the time of year. See our website for details.

- A **minimum charge** applies for the barns of £550.00 / £750.00\* for the entire barn complex, sometimes reduced to £150.00 for just the camping and bunk barn in the very low season.
- Groups please see our barn booking form to calculate details of the charges.
- A **weekend rate applies** to Saturday events with a reduced rate for Friday setup.
- A **refundable bond of £100** is required.

### Payment and arrival:

1. A **deposit\*\* of at least £500** is due with the completed barn booking form.
2. **The balance due plus the bond** is due 4 weeks prior to arrival, based on estimated numbers.
3. **On arrival** go to the campsite reception and you will be escorted to the barns and given a barn arrival inspection sheet as well as keys to the outside doors.
4. **On leaving** go to reception, the barns will be inspected, adjustments to numbers confirmed and the bond refunded.
5. A **payphone** is in the camping barn. Groups staying a week or more can have a non-payphone installed in which case they pay actual charges + 50%, which is cheaper than payphone rates. Phone charges are then invoiced and the bond refunded when payment of this invoice is made.

\* This is low / high season rate where the high season is bank holidays and July 15 – September 3<sup>rd</sup>.
